Rather, it is a congressional grant of federal jurisdiction and was enacted merely as a codification of the existing diversity rule. See *Carden v. Arkoma Assocs.*, 494 U.S. 185, 187-89, 110 S.Ct. 1015, 1017-18, 108 L.Ed.2d 157 (1990). The Supreme Court has noted that the language of the diversity statute does not limit the federal courts' power to hear diversity cases. See *Bergen v. Spaulding*, 129 U.S. at 537, 9 S.Ct. at 258. In addition, the emphasis in the statute on presence of parties indicates that Congress did not intend the diversity statute to bar diversity actions by plaintiffs who are citizens of the forum state and defendants who are citizens of a different state. See also *Mohawk Indus., Inc. v. Carpenter*, 464 U.S. at 8, 104 S.Ct. at 3046 (holding that diversity jurisdiction exists over claim of misappropriation of trade secrets, noting that "the existence of an alternative state law claim [does not] prevent the maintenance of an otherwise legitimate action in the federal court on the basis of diversity jurisdiction"); *Verlinden*, 461 U.S. at 486 n. 6, 103 S.Ct. at 1969 n. 6 (holding that misappropriation of intellectual property under the laws of the Netherlands was a federal question because the "sales agent" of the plaintiff also resided in the United States); *Moore v. Townsend*, 525 F.Supp. at 33 (holding that the diversity statute allows suit by a state to protect its citizen against violation of its law). 18 We read the diversity statute as not providing an absolute bar against diversity suits by forum residents. The construction of the federal and state laws is a matter for the courts in a particular case, not the unbridled authority of a court en banc. Cf. *Connecticut Mut. Life Ins. Co. v.
