

Moreover, even if we were to find that a special relationship existed, we are of the opinion that G.L. 1956 § 9-25-3(a) bars claims for damages against a manufacturer only when the design defect in the manufactured product is an "unavoidable unsafe condition." Stavola v. Rockwell International, Inc., 110 R.I. 451, *49 456, 293 A.2d 912, 915 (1972). On the record before us, we find that plaintiff did not present sufficient evidence to create a jury question on this issue. The defendants also argue that the evidence presented at trial failed to establish any causal link between the plaintiff's injury and the medical treatment she received from Dr. Shelton. In denying defendants' motion for directed verdict, the trial justice stated that there was enough evidence to present the issue to the jury. Specifically, the judge cited the testimony of plaintiff's medical expert, Dr. Sleek, which, when read in its entirety, established a causal connection between the medical treatment and the harm sustained by the plaintiff. The plaintiff's expert witness, although admitting that he could not opine about the cause of plaintiff's hernia, was of the opinion that a few days of medical treatment, a minor procedure such as a cystoscopy, and Dr. Shelton's treatment of this condition, were the cause of the condition. We are of the opinion that the defendants' argument must fail. The evidence presented on the issue of causation established that plaintiff's injury resulted from repeated bowel movements. We believe that plaintiff met her burden of producing sufficient evidence to permit a reasonable trier of fact to conclude that the cause of the plaintiff's injury was medical treatment for the ailment. Thus, the evidence would support a finding that the defendant was negligent. It is well settled that, in a negligence action, only
